Adriansyah Chaniago memperoleh gelar sarjana Ekonomi Pembangunan dari Universitas Padjadjaran, Indonesia. Beliau diangkat sebagai Komisaris Independen dan Ketua Komite Audit PT Jasa Marga Persero Tbk (Badan Usaha Milik Negara), masing-masing di bulan Juni dan Juli 2020.

Pada bulan Desember 2017, beliau diangkat sebagai Chief Executive Officer dari Samudra Energy Limited..

Adriansyah Chaniago graduated from University of Padjadjaran, Indonesia with bachelor degree in Development Economic. He was appointed as the Independent Commissioners and Chairman of the Audit Committee of PT Jasa Marga Persero Tbk (a State Owned Enterprise) in June and July 2020, respectively.

Since July 2020, he is also acting as a Commissioner of PT Samudra Energy.

He started his career as Junior Economist in PT Pedicinal Bandung from October 1990 until March 1991. After than he joined PT DBS Securities Indonesia as Manager, Deputy of Head of Research in 1991 and moved to PT Bahana Securities as Assistant Vice President in April 1997.
